CONDITIONS OF INFORMAL ADJUSTMENT

You are hereby placed on informal probation for a period of _____ by the Court under the following conditions:

1. General Behavior:
 - a. You must obey all laws.
 - b. You must keep your parent/guardian informed of your whereabouts at all times.
 - c. You must participate in an educational program and follow all attendance and behavior expectations. If you have obtained your high school diploma or High School Equivalency, you must participate in a vocational program or maintain employment.

2. Residence:
 - a. You must live with your parent/guardian. Any change in who you reside with must be approved by your Probation Officer.
 - b. You must notify your Probation Officer within 24 hours of any change in address or phone number.
 - c. You cannot leave the State of Indiana without receiving permission from the Court.

3. Reporting and Visits:
 - a. You must report in person to the Probation Department as required.
 - b. While on probation, a Probation Officer may visit you at any location, including your home, school, or work site.

4. Case Plan / Treatment Plan:
 - a. You must work with your Probation Officer and/or service provider to develop and participate in a plan of care that will help you be successful.
 - b. Probation has the authority to address non-compliance issues by giving sanctions (consequences). You are expected to comply with all sanctions that are agreed to during the process. If you choose not to participate in the sanctions process, a Petition to Modify (violation) may be filed.

5. Alcohol, Drugs, and Weapons:
 - a. You shall not possess or use illegal drugs, controlled substances (without a prescription), and alcohol or cannabinoid oil (CBD) products. Additionally, any form for medication assisted treatment (MAT) must be approved by the Probation Department and/or Court.

- b. You must submit to observed urine drug testing and pay the costs associated with all tests.
- c. You shall not possess or be around anyone in possession of a gun, rifle, shotgun or other dangerous weapon, including ammunition and look-a-like weapons.
